SUMMARY

Final Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.20 per Offer Share (being the mid-point of the Offer Price range) (exclusive of 1% brokerage fee, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.20 per Offer Share, the net proceeds from the Share Offer to be received by the Company and after deducting the net proceeds from the sale of the Sale Shares under the Share Offer, the underwriting fees and commissions and estimated expenses payable by the Company in relation to the Share Offer, is approximately HK\$38.4 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.

Over-subscription

- A total of 3,728 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 699,560,000 Public Offer Shares, equivalent to approximately 20.0 times of the total number of 35,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer - Re-allocation of the Offer Shares between Placing and Public Offer” in the Prospectus have been applied. Based on the Offer Price of HK\$0.20 per Offer Share, the net proceeds from the Share Offer to be received by the Company and after deducting the net proceeds from the sale of the Sale Shares under the Share Offer, the underwriting fees and commissions and estimated expenses payable by the Company in relation to the Share Offer, is approximately HK\$38.4 million. - approximately HK\$22.0 million (or approximately 57.3% of the net proceeds to be received by the Company) will be used for acquiring a new factory premises as the Group’s new cold storage warehouses;
- approximately HK\$8.8 million (or approximately 22.9% of the net proceeds to be received by the Company) will be used for renovating the new premises as a refrigeration facility;
- approximately HK\$2.4 million (or approximately 6.3% of the net proceeds to be received by the Company) will be used for strengthening the Group’s logistics team;
